The following courses do not have final exams scheduled in the exam period:

1. All clinics-no exam

Summer Term Policies:

1. **Credit hour limit:** Students in the American JD program may enroll a maximum of nine (9) credits in the Interession and Term III combined. Students in the American and Canadian JD program may enroll in a maximum of ten (10) credits in the Interession and Term III combined.
2. **Financial aid:** Students must enroll in a minimum of three (3) credits to be eligible for financial aid.
3. **Course cancellation:** Courses with an enrollment of less than ten (10) students (except the Clinics) are subject to cancellation.
4. **Absence policy:** Students are not permitted any absences in the Interession classes or Immersion courses.
5. **Online Courses:** To enroll in online courses, all students must have **earned** a minimum of 28 credit hours at the time of registration. F1 status students (international students) may enroll in only one online course, up to 3 credit hours per Term (8 CFR 214.2 (f)). US students may enroll in more than one online course per Term. No student may earn more than a total of 15 online course credits towards graduation.

Summer Clinic Requirements:

Family Law Clinic: Students must complete a minimum of 105 work hours and must be available for court on Tuesdays from 2 to 4 and Thursdays from 11 to 4.

Housing Law Clinic: Students must complete a minimum of 105 work hours (primarily during business hours).

Criminal Trial Clinic: Students must be available on Wednesday mornings and must also complete a minimum of 105 work hours primarily during business/court hours. There will be a mandatory court date on May 23, 2018.

Pro Se Clinic: Students must be available Monday and Wednesday afternoons from 12:30 to 5:00., and must complete a minimum of 105 work hours. Students must register for this clinic through Prof. Anne Yantus, Dir. of Clinical Programs.
