Summer Term Policies:

1. **Credit hour limit:** Students in the American JD program may not enroll for more than nine (9) credits in the Intersession and Term III combined. Students in the Canadian and American Dual JD program may not enroll for more than ten (10) credits in the Intersession and Term III combined.
2. **Financial aid:** Students must enroll in a minimum of two (2) credits to be eligible for financial aid.
3. **Course cancellation:** Courses with an enrollment of fewer than ten (10) students (except the Clinics) are subject to cancellation.
4. **Absence policy:** Students are not permitted any absences in the Intersession classes.
5. **Mediation Training:** Enrollment in Mediation Training cannot exceed 18.

- 6. Children & the Law:** This version of Children & the Law (offered only by Professor Paruch) will satisfy the upper-level writing requirement. The course work will continue after the Intersession, into the regular Summer Session, per Professor Paruch's instructions.
- 7. Other course enrollment limits:** Trial Practice is limited to twelve (12) students. The Criminal Trial Clinic is limited to five (5) students
- 8. Australian Law & the Constitution:** Meets only on July 12, 13, and 14. Attendance is mandatory each day – no absences are permitted.
- 9. Detroit Revitalization: the Role of Urban Agriculture: Meets only on June 16, AND June 19-23.** Attendance is mandatory each day – no absences are permitted.
