#### PLEASE NOTE THE FOLLOWING:

1. Limitations on online course work: Several of our classes for Term III are offered as online courses.

- a. Students in the **JD** Program are limited to 45 credits of online courses out of their 90 credits required for graduation.
- b. Students in the **Dual JD** Program are limited to 30 credits of online courses out of their 60 Detroit Mercy Law credits required for graduation.
- c. Students who have an F1 visa or are in the Dual JD Program are limited to one online course (up to 3 credits) per term.
- 2. **Term length:** Term III is a seven-week term that runs from May 27 to July 24, 2025. Note that some classes may have a make-up day for holidays.
- 3. **Credit hour limit:** Students in the **JD** program may enroll a maximum of **nine (9)** credits in Term III. Students in the **Dual JD** program may enroll in a maximum of **ten (10)** credits in Term III.
- 4. **Financial aid:** Students must enroll in a minimum of three (3) credits to be eligible for US Federal Financial Aid.
- 5. **Course cancellation:** Courses with an enrollment of less than ten (10) students (except the Clinics) are subject to cancellation.
- 6. **Clinics:** Registration for clinics first requires application to Assistant Dean Nowak. Please make sure to consider whether the clinic requires specific days/times for clinical work (see below). Students will know clinic choices before registration.

### **Courses with special meeting dates:**

1. **Selected Topics in Children and the Law Seminar [3 cr]** will meet **online** with an intensive introductory session May 27-30 and June 2-6 held from 9:00 AM to 12:30 PM each day. Students will also meet with Prof. Paruch at least 4 hours for seminar paper conferences throughout the remainder of the semester and participate in 3 hours of final presentations during exam week. Students will be expected to spend at least an additional 89 hours outside of class meetings preparing for class and researching, writing, and revising their seminar papers.

- 2. **Mediation Training [2 cr]:** This 2-credit course is P/NP and serves as a 40-hour General Civil Mediation Training for the Michigan State Court Administrative Office (SCAO). The class meets **primarily in-person** at the Law School, with the final two course sessions **online**. Specifically, the class will meet in person on June 2 ,3, 4, 5, 6 and June 9, 10, and 11 from 9:00 a.m. to 1:00 p.m. and virtually on June 13 from 9:00 a.m. to 1:30 p.m. and June 14 from 10:00 a.m. to 3:30 p.m.
- 3. Access to Justice Practicum [1 cr]: The one-week expungement clinic will be offered during the summer term. There will be a 90-minute mandatory class on Thursday, June 5. The week that students will travel to participate in the clinic is still being worked out. This course will be limited to 6 students. Further information regarding the course and how to apply for it will be sent separately by Assistant Dean Nowak. The application and registration for this course is similar to that of the clinics.
- 4. **Role of Detroit Urban Agriculture [1 cr]:** This one-week, one-credit course is P/NP. It will be held June 23-27 and will require students to travel around Detroit to visit with urban farmers and learn about urban agriculture. Students should plan on 10:00 a.m. to 4:00 p.m. for class.

#### **Summer Clinic Requirements:**

**Family Law Clinic**: In addition to class time, students must be available on Tuesdays from 10:00am to 3:30pm or 4:00pm, and Thursdays from 12:00pm to 3:30pm or 4:00pm, to perform clinical hours at the William Booth Legal Aid Clinic located at 3737 Lawton St, Detroit, MI 48208. The clinic is a 5-minute drive from the law school and has parking available. Class meets during this time on Tuesday. Students must complete a minimum of 105 work hours.

**Criminal Trial Clinic:** Students must be available at least 12 hours per week from 8:30am to 12:30pm to be in court via Zoom at 36th District Court in Detroit. Students must be available on Thursdays from 8:30am to 12:30pm to appear in person at the 52nd-4 District Court, located at 520 W. Big Beaver Road, Troy, MI 48084. Students will also be required to do some clinical hours outside of class. Students must complete a minimum of 105 work hours.

**Pro Se Clinic:** The Pro Se Clinic is open Monday, Wednesday, and Friday from 1:00 to 5:00pm and is in Room 768 of the United States District Court, 231 W Lafayette Blvd, Detroit, MI 48226. Students must participate in three clinic triage meetings (1 of the 3 weekly triage sessions may be on zoom) to prepare for each Clinic Day from 12:30 to 1:00pm. Students must work in—person at the clinic at least two clinic days. Students will coordinate coverage of the clinic for all 3 days at the beginning of the semester.
