### IMPORTANT INFORMATION

- 1. This is a draft schedule. There could be changes, although we will attempt to keep them to a minimum.
- 2. Students will be given the opportunity to preregister for clinics. All clinics have additional hour requirements beyond the class times, and some have specific time periods in which the work must be done. Please check the accompanying clinic information document to learn of those requirements. Registration for clinics will occur at the end of May. More information will be circulated closer to the registration for clinics.
- 3. After registration for clinics occurs, 3Ls will be able to preregister for LFPs.
- 4. Priority for clinics and LFPs is given to those graduating in December. There will be sufficient clinical and LFP offerings in the Winter 2025 Term to ensure that all graduating students satisfy the graduation requirements.
- 5. Registration for other courses will be July 2 July 10. Dean Khan will be emailing the specific dates for registration, which depend on the credit hours earned by students.
- 6. Please read the General Guidelines for Course Selection for the JD and Dual JD programs that accompany this schedule as well as the list of courses that describes the types of courses and the draft list of courses expected to be offered in the Winter 2025 Term.
- 7. Please pay attention to prerequisites when registering. For example, Trial Practice requires students to have either taken Evidence or be taking it in the same term as the Trial Practice Course. The Criminal Trial Clinic requires Evidence as a prerequisite.
- 8. There will be academic advising sessions on Zoom in June. Deans Henning, Humphrey, and Khan are also available for individual appointments for the JD program. Director Fisher is available for individual appointments for the Dual JD program.
