

IMPORTANT INFORMATION

1. This is a draft schedule. There could be changes, although we will attempt to keep them to a minimum.
2. There will be advising sessions online as follows:
 - May 19 at 1:00 p.m.: Dual JD Advising Session
 - May 20 at 1:00 p.m.: U.S. JD Advising Session
 - May 21 at 1:00 p.m.: Clinical Offerings Advising Session
3. Students will be given the opportunity to preregister for clinics. All clinics have additional hour requirements beyond the class times, and some have specific time periods in which the work must be done. Please check the clinic information document sent from Director Nowak to learn of those requirements. **Registration for clinics will open May 26 and applications will be due May 29.** The clinic will email offers to students the end of the first week of June and acceptance of offers will be due June 8.
4. After registration for clinics occurs, 3Ls will be able to preregister for LFPs if they have not yet registered for an LFP. The LFP form will be emailed to 3Ls on June 9 and will be due on June 11.
5. Priority for Fall 2026 (Term I) clinics and LFPs is given to those graduating in December. There will be sufficient clinical and LFP offerings in the Winter 2026 (Term II) to ensure that all graduating students satisfy the graduation requirements.
6. Registration for other courses will be July 6 – July 9. Dean Khan, the Registrar, will be emailing the specific dates for registration, which depend on the credit hours earned by students.
7. Please read the General Guidelines for Course Selection for the JD and Dual JD programs that accompany this schedule on the Law Registrar's website.
8. Please pay attention to the exam schedule at the end of this document when considering your course schedule. There is also a list of which courses do not have exams scheduled for the final examination period.
9. Please pay attention to prerequisites when registering. For example, Trial Practice requires students to have either taken Evidence or be taking Evidence in the same term as the Trial Practice Course. The Criminal Trial Clinic requires Evidence as a prerequisite.
